MARKETPLACE EVENTS

Exhibitor Requirements:

- 1. EVERY exhibitor must participate in a daily individual health-screening questionnaire.
- 2. EVERY exhibitor is required to wear a face mask when inside the facility.
- 3. Consider wearing gloves.

4. Wash hands frequently with soap and water for at least 20 seconds or use 60% alcoholbased hand sanitizer often.

5. If you're feeling ill or have a temperature of 100.4 or above, you must stay home and have another employee work the Show in your place.

6. Always sneeze &/or cough into a tissue and immediately throw the tissue into the trash.

8. Offer digital content via email including business cards, brochures etc.

9. Avoid trick-or-treat style giveaways including swag, candy, beverages, etc. Candy bowls will not be permitted. Consider individually distributing hand sanitizer, gloves and/or facemasks instead.

9. Avoid physical contact including handshakes, high fives, embraces, etc. Practice physical distancing of at least 6 feet. Aisles have been increased to 20' to accommodate this.

10. Wipe down and sanitize all samples, products, writing devices, tablets and merchandise after every use.

11. Chairs should be for your personal use, not for attendee use. If an attendee is to sit in your booth space, ensure that you thoroughly sanitize the entire surface of the seat/chair after each use.

12. Do not touch your face.

13. No handing out printed material

14. If you are directly selling products at the show, it must be a cashless sale.

15. If you suspect you have been in contact with someone who has tested positive for COVID-19 or someone who has exhibited symptoms of COVID-19 within 21 days of the Home Show, you MUST have another employee work the show in your place. 16. Food Sampling:

• Follow all the PCC's policies for concessions and bar service.

• Entity distributing sample item(s) must have a Maricopa County Environmental Services Temporary Food Service Establishment permit and must provide a copy certificate to Aventura...A Premier Catering Company no later than fourteen (14) days prior to event.

• Hand washing stations are required for samples that are not pre-packaged off site per Maricopa County guidelines

- Sampling by exhibitors is allowed, but must adhere to:
 - Exhibitor MUST wear gloves and a facemask and change gloves often.
 - Exhibitors should wash their hands after removing gloves.
 - Exhibitor ust not directly handle food items, the use of tongs and/or utensil is required.

• All samples MUST be served in a disposable "ketchup cup" aka condiment paper/plastic cup with a lid.

- A sneeze guard is mandatory where consumables are present.
- Consumable items MUST be stored away from the public. Consumables will be given to consumers upon request for sample.
- Your booth must be wiped clean and sanitized often.

17. In order to maintain physical distancing, limited booth workers are permitted to work on Show days. Show Management may make exceptions if the booth workers are cohabiting in the same household. Revised worker numbers:
