

Marketplace Events Escape to Island of Bryan Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, PROVINCIAL, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes the entrant's full and unconditional agreement to and acceptance of these Official Rules. The Escape to Island of Bryan Sweepstakes (the "Sweepstakes") begins at 12:00 a.m., Eastern Time ("ET") September 1, 2023, and ends at 11:59 p.m. ET on April 14, 2024 ("Sweepstakes Period"). The Sweepstakes is sponsored by Marketplace Events (the "Sponsor"), 2000 Auburn Drive, Suite 200, Beachwood, OH 44122 USA.

Eligibility: Sweepstakes is open to legal residents of Canada (excluding Quebec) who have reached the age of majority in his or her province of residence as of the time of entry. How to Enter: During the Sweepstakes Period, eligible participants will be invited to enter the sweepstakes by logging on to the show's website and filling out all the required fields on an online entry form to receive one (1) entry into the sweepstakes. Entry forms will also be available to fill out at various show locations that Marketplace Events will be exhibiting at during the Sweepstakes Period. Only one entry per person is permitted. If multiple entries are received from the same person, only the first entry will be accepted, and additional entries will be disqualified. Multiple participants are not permitted to share the same email address. Any attempt to obtain more than one entry by using multiple/different email addresses or other methods may void all your entries, and you may be disqualified from the Sweepstakes.

Drawing and Notification: One (1) potential Grand Prize Winner will be selected from among all eligible entries received, in a random drawing conducted on or about April 19, 2024, by an independent judging organization, whose decisions are final in all matters relating to this Sweepstakes. Odds of winning will depend on the total number of eligible entries received. Potential winners will be notified by the email address they provided on the Sweepstakes entry form. Before being declared a winner, the selected entrant(s) shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail.
