

Marketplace Events AZ Wedding Show Sweepstakes Official Rules

The "AZ Wedding Show" Sweepstakes (the "Sweepstakes") begins at 11:59 a.m., Mountain Time ("MT") January 1, 2023 and ends at 3:00 p.m. MT on January 8, 2023 ("Sweepstakes Period").
