

Marketplace Events AZ Wedding Show Sweepstakes Official Rules

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. The "AZ Wedding Show" Sweepstakes (the "Sweepstakes") begins at 12:00 a.m., Mountain Time ("MT") November 17, 2021 and ends at 11:59 p.m. MT on January 9, 2022 ("Sweepstakes Period").
