In response to your correspondence dated November 27, 2018, the Canada Border Services Agency (CBSA) -International Events and Convention Services Program (IECSP) officially recognizes the following event:

## EDMONTON RENOVATION SHOW

January 25 - 27, 2019 **Edmonton EXPO Centre** Edmonton, Alberta

The information provided to CBSA states there will be approximately 20,000 attendees of which .01% are foreign to Canada and that the event is open to the general public with sales.

As outlined in your correspondence, this event is expecting approximately 3 foreign exhibitors who are importing display booths, signage, computers, printed advertising materials, and industry related goods for use at the event.

It should be noted that non-Canadian exhibitors may import display items and exhibit booths temporarily as outlined in the provisions of tariff classification 9993.00.00 duty free on the condition that the goods will be exported from Canada upon the completion of the event.

Goods imported "for sale" are not eligible under tariff No. 9993.00.00.00. These goods must be accounted for at time of release on a Form B3, Canada Customs Coding Form. Commercial release processing is fully explained in Customs Memorandum D17-1-5.

Goods imported as "giveaways" must be accounted for at time of release on a Form B3, Canada Customs Coding **Form** with all applicable duties and/or taxes collected at the time of importation.

Davidson & Sons Customs Brokers Ltd. has been designated as the official customs broker for this event. If you have any questions regarding importing meeting materials into Canada or if you wish to inquire as to their brokerage services provided, please contact Remy Perrot at 604-697-2595 (Tel) or 604-505-5717 (Cell)

CBSA requires everyone seeking admission into Canada to properly declare themselves to CBSA by providing accurate identification. CBSA will accept a valid passport as proof of citizenship.

Foreign nationals may engage in exhibiting, selling, or displaying goods without a work permit provided they are not selling to the general public. Direct sales to the general public will require a work permit. For more information, please visit: www.cic.gc.ca/english/work/index.asp

They will assess the visa requirements of your event.

To facilitate border procedures it is recommended that exhibitors, carriers, organizations, and attendees be provided a copy of this letter for presentation to a CBSA Border Services Officer upon their arrival to Canada. In conjunction with the presentation of this Recognition Letter, an itemized list of goods including a description, country of origin, quantity and value is required for presentation to CBSA. If your event materials will be imported by a commercial carrier or courier service, a copy of this letter should also be attached to any shipping documents.
