Cincinnati Sportscapes Pickleball Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility: Sweepstakes is open to all legal residents of Ohio, Indiana, and Kentucky, who are 18 years of age or older as of February 17, 2023.
